Notice of Right to Cancel Instructions

All customers must be provided with both a verbal and written Notice of Right to Cancel for any sale conducted outside a standard place of business (e.g. in a customer's home, at a state fair, at a trade show, expo, etc.).

If you do not have your own Notice of Right to Cancel, you may use the notice provided on the following pages. For each transaction, complete the following fields:

- Date of Transaction
- Business/Seller Name
- Seller's Street Address, City, State, and Zip Code
- Not Later than Midnight of Date

You will need to retain the merchant copy and provide the buyer(s) with two copies. If the buyer wishes to cancel the transaction, they must sign one document to mail to your business and retain the second copy for their records. The buyer should only sign the document if they wish to cancel the transaction.
